

Marina Rules

- All vessels at Harbour West Marina and Storage must provide the office with current insurance certificates with a minimum of \$2 Million General Liability. It is the responsibility of the customer to provide updated certificates upon expiry.
- Fishing is prohibited within the marina and 210 Hillyard St.
- Swimming is prohibited within the marina and 210 Hillyard St.
- Designated customer parking is available at the 210 Hillyard storage facility. Any vehicle that is parked outside of the designated spaces may be required to have their vehicle moved at the customer's expense should it impede marina operations or emergency access.
- Customers will inform the marina when leaving on any extended trip so that the marina may make that slip available for transient docking in their absence.
- If leaving your vehicle in the parking lot while you are on an extended trip it is encouraged to
 provide a set of car keys to the marina office in case of emergency where your vehicle must be
 moved.
- Recycling and garbage disposal are located between the marina parking and the entrance to the docks.
- To keep the docks, clean and safe, there is to be no personal items, supplies or dock boxes placed on the dock. Any Items not approved will be removed by the marina.
- As a courtesy to all boaters, quiet hours will be observed between **10:30 PM** and **7:30 AM**. Exercise good judgement in the operation of generators, engines, radios, etc.
- All personal open flame barbeques are prohibited on the docks and marina areas. Only propane
 fueled marina barbeques located adjacent to the amenities building are permitted for use within
 the marina.
- No oil, flammable liquids, contaminated bilges or other liquids are to be discharged within the marina.
- Any painting, sanding or repairing of vessels must be done in an isolated area and adhere to the
 guidelines set forth in our Clean Marina policy. If any major work is being done it must be
 discussed with the office prior to any work being started. For information on the Clean Marine
 program please contact the marina office.



- Young children must be accompanied by an adult at all times and must wear personal flotation devices when near the water.
- Pets are allowed within the marina once their owner has submitted a pet approval form to the
 marina office. Owners must have pets leashed while on marina property and are responsible for
 cleaning up after their pet. The marina supplies dog waste bags for customer use at designated
 dog walking area.
- Laundry shall not be hung out vessels, docks or other structures within Harbour West Marina.
- There is no wake while boating within the marina. Please do not exceed 5 KM/H.
- It is the responsibility of the boater to ensure that mooring lines are an adequate gage for the size of the vessel, are in good condition and used properly.
- Boaters are responsible for their guests at all times while visiting Harbour West Marina.
- All ramps, machinery and equipment owned by Harbour West Marina may only be used by marina staff. If a customer requires service they can contact the marina office during business hours for assistance.
